Captain Charles Moore, Algalita Marine Research Foundation

Captain Charles Moore is the founder of Algalita Marine Research Foundation in Long Beach, California, established in

1994. In 1995 he launched his aluminum hulled research vessel, *Algalita*, in Hobart, Tasmania. Since then he has logged over 100,000 miles of

research voyages aboard. His 1999 study shocked the scientific world when it found 6 times more plastic fragments by weight in the surface waters of the central Pacific than the associated zooplankton. Captain Moore's papers on oceanic plastic particulate pollution, published in *Marine Pollution Bulletin*, and his review article "Synthetic polymers in the marine environ-

ment: A rapidly increasing, long term threat," published in *Environmental Research*, contributed to his reputation as a world-renowned investigator in this field. His work has been featured on Nightline, Good Morning America, National Public Radio, Rolling Stone, and The Wall Street Journal, and the National Geographic special "Strange Days on Planet Earth."
